

ANNOUNCEMENT REGARDING FITCH RATINGS

September 9, 2022 – Fitch Ratings ("Fitch") maintains Anadolu Efes' Long-Term Foreign-Currency Issuer Default Rating and Local Currency Issuer Default Rating at BB+ on Rating Watch Negative while National Rating remained at AAA(tur), the highest rating in the rating scale.

While Anadolu Efes' liquidity was evaluated as adequate, Company's strong resilience amidst a challenging input cost environment and market share gains in core markets were highlighted in the Fitch's report.
