4. GROUP HEALTH & SAFETY POLICY

4.1 Definition of Policy

- People are Anadolu Efes most important asset and their health and safety is greatest responsibility for Anadolu Efes leadership.
- Anadolu Efes, will strive to prevent all accidents, injuries and occupational illnesses within its operations by working vigorously to achieve high standards of occupational Health and Safety throughout the organization.
- At Anadolu Efes, Occupational Health and Safety Program is based on the belief that the well-being of employees and partners influenced by Anadolu Efes work environment, is a major priority.
- Anadolu Efes is committed to create and maintain an integrated program and culture to provide a healthy and safe working environment for all employees, partners and public.
- Anadolu Efes proactively and continuously improves Health and Safety Practices by implementing OHSAS 18001 Standard, new technologies, risk assessments and mitigation techniques.
- This is all about life of employees and customers, therefore Anadolu Efes management believes involvement of employees, suppliers, customers and all other partners is so crucial for a work environment to be as safe as home.

4.2 Governance

- Anadolu Efes conducts its activities related to occupational health and safety in strict compliance with regulations and legislation and where legislation does not exist; takes the responsibility and sets its own strict standards to prevent accidents and injuries.
- Anadolu Efes establishes risk-oriented H&S management systems; ensures system reliability with internationally recognized certifications such as ISO 18001 or similar and assures integrity via internal and external audit mechanisms.
- Anadolu Efes Group Supply Chain is responsible for definition of functional strategies and commitments, working norms, application frameworks and long-term goals on H&S management. Action plans are determined together with each Country Operation with regard to corporate strategies and commitments and Country Supply Chain teams are responsible for the execution of these plans. H&S Committees, established within the country operations, support facility management in their projects. Experiences regarding performance improvement practices are shared during organised field visits.

- Performance & continuous improvement in the way of H&S, is tracked regularly in Anadolu Efes
 reporting systems and realization of targets is linked to performance evaluation and remuneration of
 our employees. H&S policies and corporate commitments are communicated with employees internally
 and training is conducted to raise awareness of.

4.4 Supplier Partnering

• Anadolu Efes encourages its suppliers and collaborates with them to improve their H&S understandings via developing supplier partnership programmes and sharing of best practices.

4.5 Community Engagement
